BRAVE TRAILS SUCCESSFULLY RAN 3 WEEKS OF SUMMER CAMP, A ONE WEEK AND 2 WEEK RESIDENTIAL PROGRAM COMBINING TYPICAL CAMP ELEMENTS AND LEADERSHIP ELEMENTS. WE RECRUITED 114 CAMPERS FROM ACROSS THE UNITED STATES AND 46 VOLUNTEER STAFF MEMBERS. WE AWARDED APPROXIMATELY \$20,000 IN CAMPER SCHOLARSHIPS TO YOUTH THAT WOULDN'T OTHERWISE BE ABLE TO GO TO CAMP. WE ALSO CONTINUED OUR YEAR-ROUND PROGRAMING, IN THE FORM OF A ONCE A MONTH MEET UP GROUPS FOR LGBTQ YOUTH AND ALLIES AGES 12-20. WE HAD A CAMPER REUNION AT WHICH 45 CAMPERS FROM ACROSS THE UNITED STATES CAME.
